

COMMERCIAL, SOLICITATION, AND EXPRESSIVE ACTIVITIES POLICY

CAPITAL IMPROVEMENT BOARD OF MANAGERS OF MARION COUNTY, INDIANA ("CIB")

The Indiana Convention Center ("ICC") and Lucas Oil Stadium ("LOS") are facilities that are publicly financed, owned, and operated; however, the areas inside the facilities are licensed for private party use and are not accessible to the general public at all times. As the ICC and LOS are under common operation and management, any collective reference thereto shall be to "ICCLOS." The Hudnut Commons is a park that is publicly financed, owned, and operated; it is located immediately north of the ICC and north of Maryland Street.

Each year, the ICCLOS is the venue for many important conventions and events that are an integral part of the City of Indianapolis's economy, bringing in hundreds of thousands of visitors and millions of dollars in event revenue to the City of Indianapolis each year. The ICCLOS competes with out-of-state venues for convention-related business in a highly-competitive market. Furthermore, the businesses and industries that use the ICCLOS for their conventions and events rely on the ICCLOS to provide a secure environment, conducive to convention-related business that does not allow interference from non-licensed commercial activities and non-commercial expressive activities. The purpose of this policy is to address non-licensed commercial activities and non-commercial expressive activities in and on ICCLOS property.

The ICC

This policy applies to the areas inside the ICC, the sky bridges leading to the ICC, and the following exterior adjacent areas (including non-public sidewalks and plazas) under the control of the ICCLOS:¹

For the areas adjacent to the ICC (see Exhibit A, aerial view), these restrictions specifically apply from the ICC property west of the Capitol Avenue right-of-way to the ICC entrances located on Capitol Avenue, south of the Maryland Street right-of-way to the ICC entrances located on Maryland Street, east of West Street right-of-way to the ICC entrance and loading docks on West Street, and north of the CSX Transportation Inc. railway to the ICC's south entrances and loading docks. The aforementioned restrictions are reflected in Exhibits A, B, C, and D, attached.

¹ Activities undertaken in the ICCLOS by individuals or entities pursuant to a license agreement entered into with ICCLOS, or other written permission granted to the individual or entity by ICCLOS, are not subject to this policy.

A. The ICCLOS prohibits any solicitation, panhandling, ticket sales, petitioning, surveying, loitering, demonstrating, campaigning, distribution of literature, or other expressive activity taking place inside the ICC, inside the sky bridges leading to the ICC as reflected in Exhibit E or inside any of the restricted areas reflected in Exhibits A, B, C, and D.

B. The ICCLOS prohibits selling or vending any merchandise or goods, including but not limited to, jewelry, tickets, food stuffs, candles, flowers, badges, and clothing, inside the ICC, inside the sky bridges leading to the ICC as reflected in Exhibit E or inside any of the restricted areas reflected in Exhibits A, B, C, and D.

C. Any individual who desires to exercise his or her rights under the First Amendment to the United States Constitution or Section 9 of the Indiana Constitution at the ICC is encouraged to do so in the Hudnut Commons Public Assembly Area, located on the south edge of Hudnut Commons to the north sidewalk of Maryland Street. The Hudnut Commons Public Assembly Area is identified in Exhibit F attached.

LOS

This policy applies to the areas inside LOS and the following exterior adjacent areas (including non-public sidewalks and plazas) under the control of the ICCLOS:

For the areas adjacent to LOS, these restrictions specifically apply from the LOS property south of the South Street right-of-way to the LOS entrances located on South Street; from the LOS property east of the Missouri Street right-of-way to the LOS entrances located on Missouri Street; from the LOS property north of the McCarty Street right-of-way to the LOS entrances located on McCarty Street; and from the LOS property west of the Capitol Avenue right-of-way to the LOS entrances located on Capitol Avenue. These restrictions do not apply, however, to the areas south of LOS on McCarty Street which are owned by unrelated entities. These aforementioned restricted areas are reflected in Exhibit G, attached.

A. The ICCLOS prohibits any solicitation, panhandling, ticket sales, petitioning, surveying, loitering, demonstrating, campaigning, distribution of literature, or other expressive activity taking place inside LOS, inside the underground connector leading to LOS from ICC or inside any of the restricted areas reflected in Exhibit G.

B. The ICCLOS prohibits selling or vending any merchandise or goods, including but not limited to, jewelry, tickets, food stuffs, candles, flowers, badges, and clothing, inside LOS, inside the underground connector leading to LOS from ICC or inside any of the restricted areas reflected in Exhibit G.

C. Any individual who desires to exercise his or her rights under the First Amendment to the United States Constitution or Section 9 of the Indiana Constitution at LOS is encouraged to do so in the LOS Public Assembly Area, located on the north sidewalk of South Street, directly across from LOS. The LOS Public Assembly Area is identified in Exhibit H, attached.

Hudnut Commons

This policy applies to the following areas of the Hudnut Commons under the control of the ICCLOS:

North of the sidewalk along Maryland Street; west of the sidewalk along Capitol Avenue; east of the entryway of the underground parking garage immediately east of the Westin hotel; and south of the outdoor seating area for Simon Headquarters. These aforementioned restricted area is reflected in Exhibit I, attached.

A. The ICCLOS prohibits any solicitation, panhandling, ticket sales, petitioning, surveying, loitering, demonstrating, campaigning, distribution of literature, or other expressive activity taking place in the restricted area reflected in Exhibit I.

B. The ICCLOS prohibits selling or vending any merchandise or goods, including but not limited to, jewelry, tickets, food stuffs, candles, flowers, badges, and clothing, in the restricted area reflected in Exhibit I.

C. Any individual who desires to exercise his or her rights under the First Amendment to the United States Constitution or Section 9 of the Indiana Constitution at the Hudnut Commons is encouraged to do so in the Hudnut Commons Public Assembly Area, located on the south edge of Hudnut commons on the north sidewalk of Maryland Street. The Hudnut Commons Public Assembly Area is identified in Exhibit F, attached.

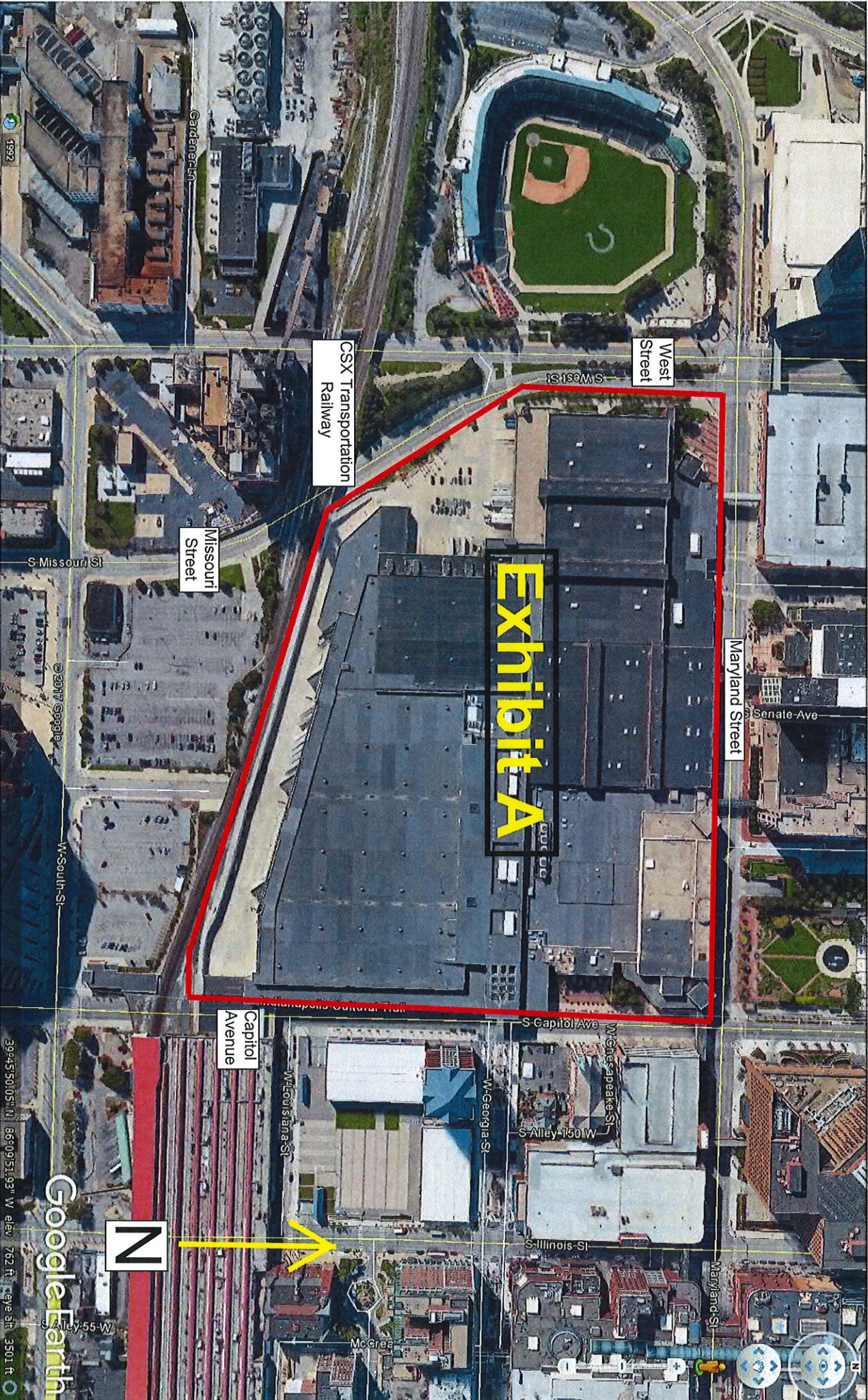

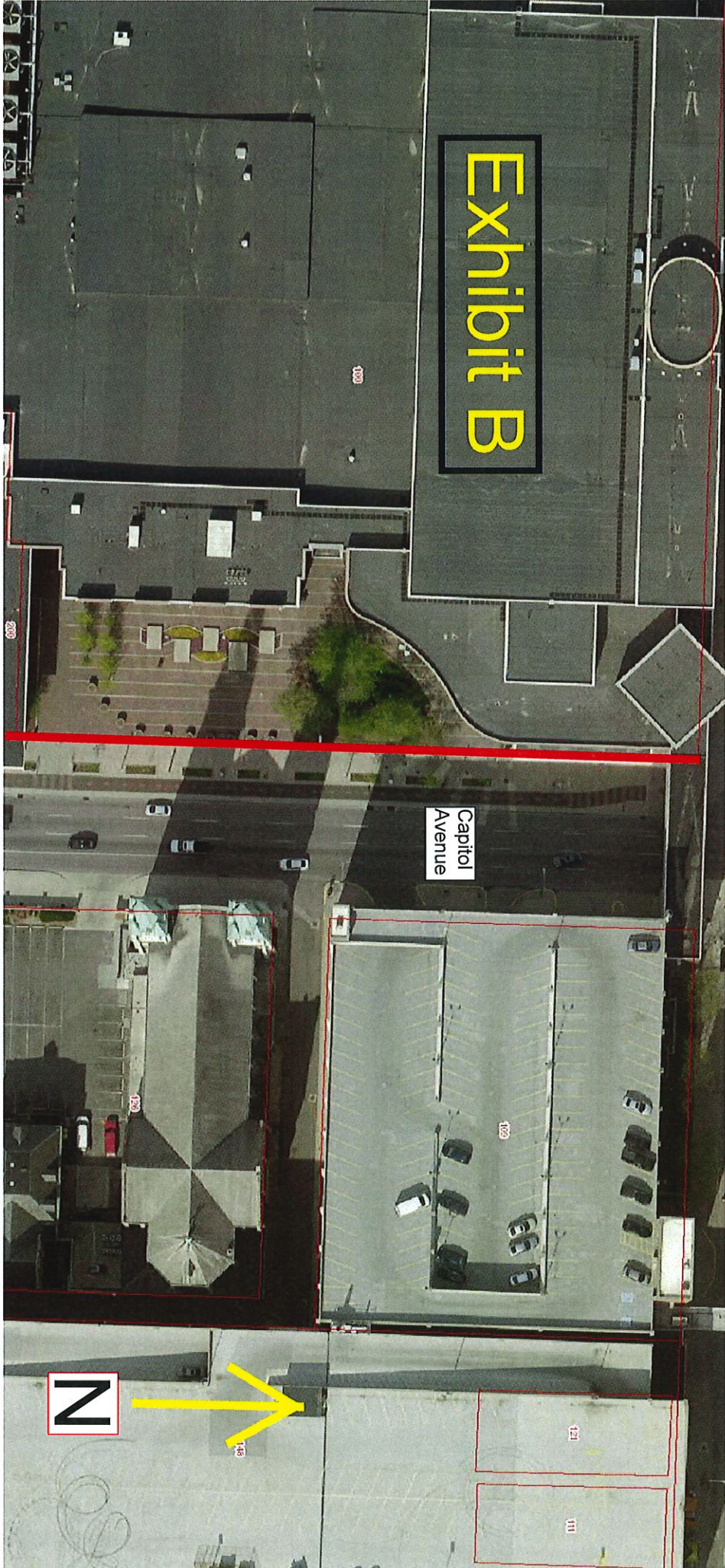

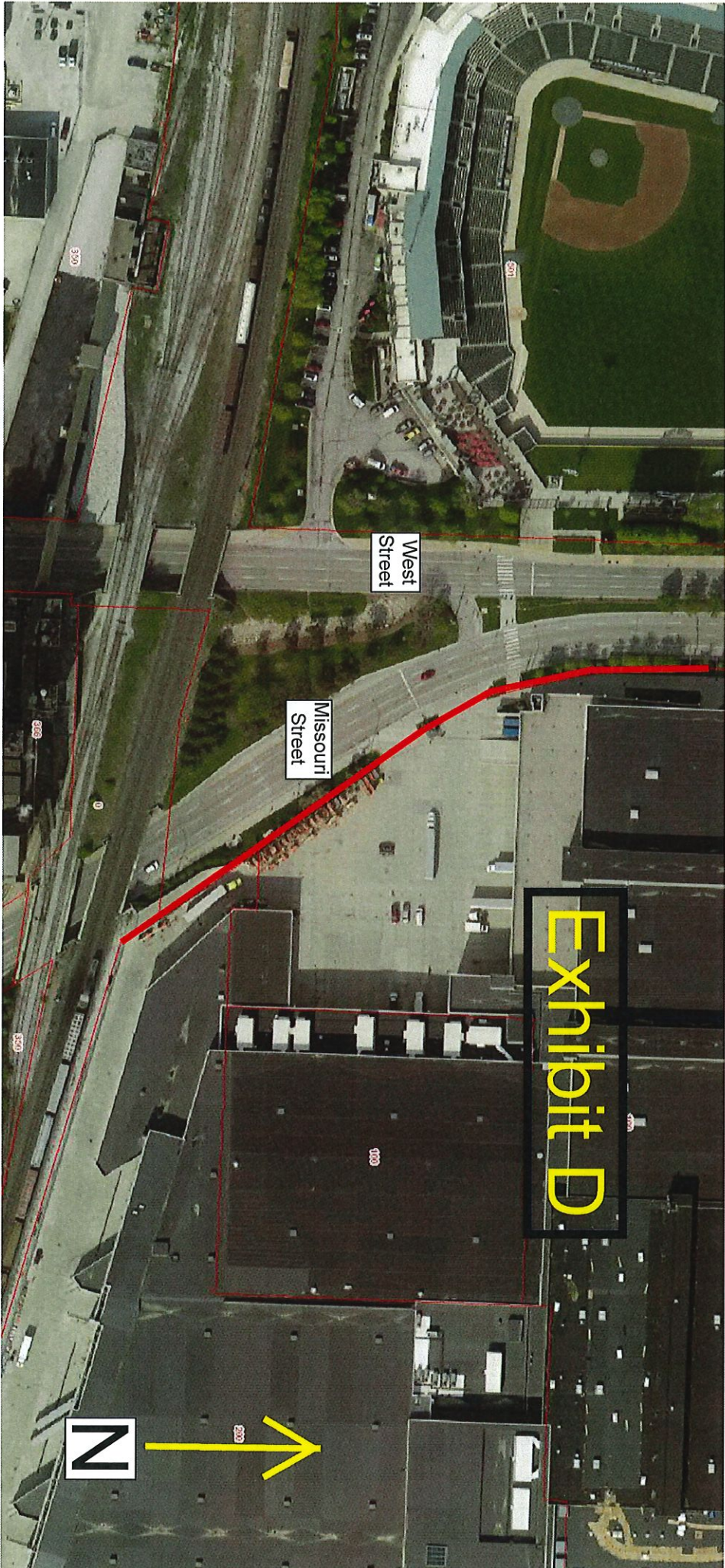

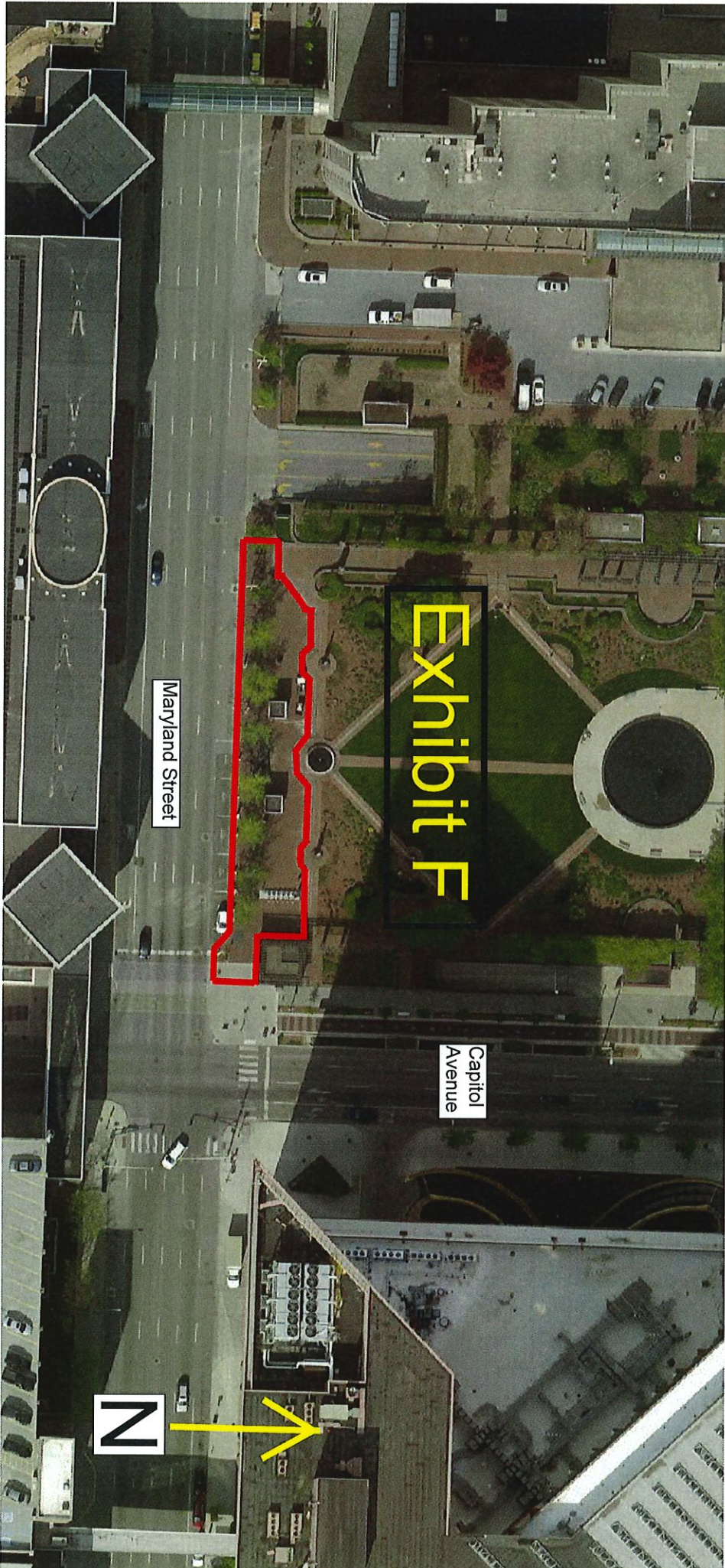

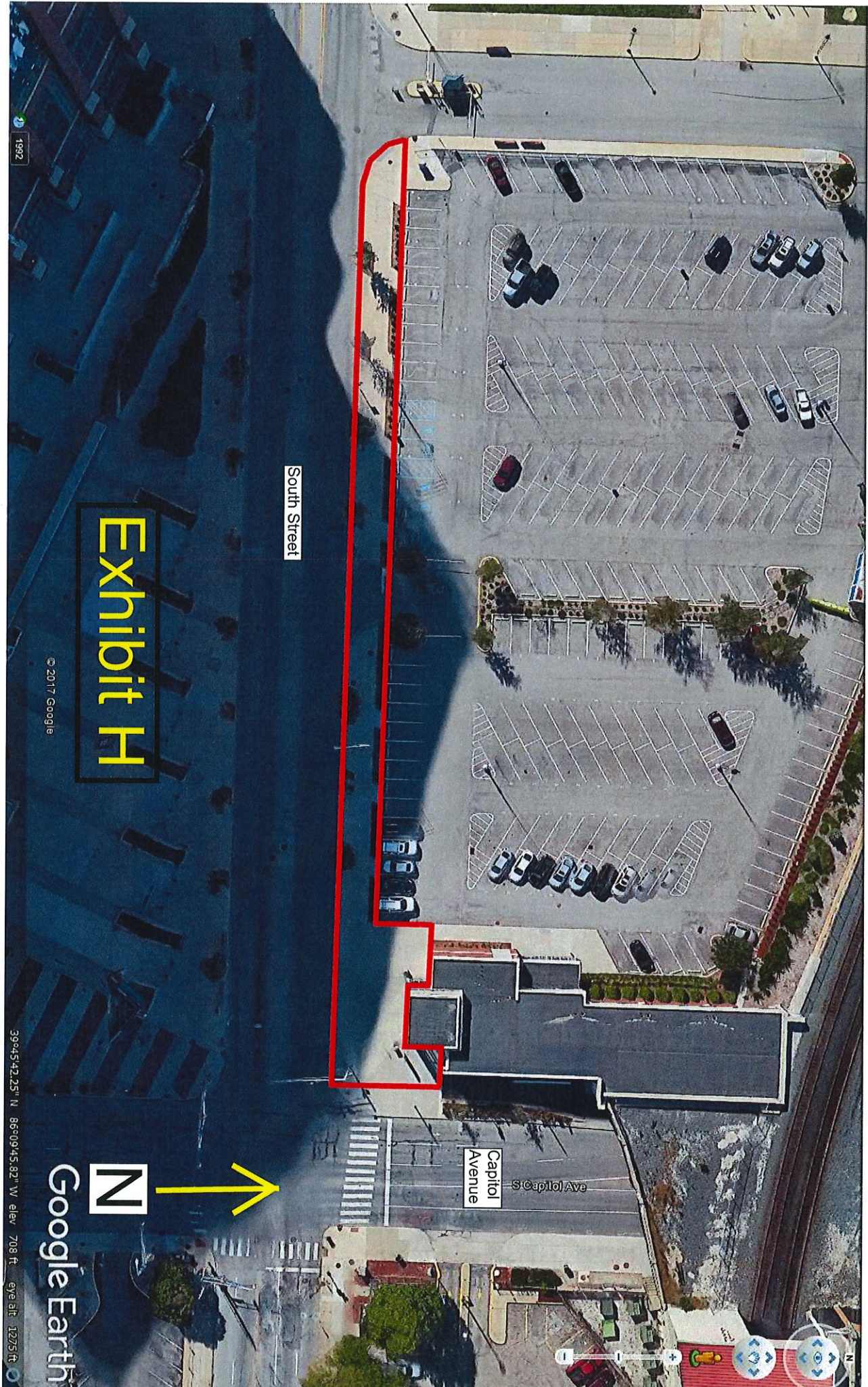

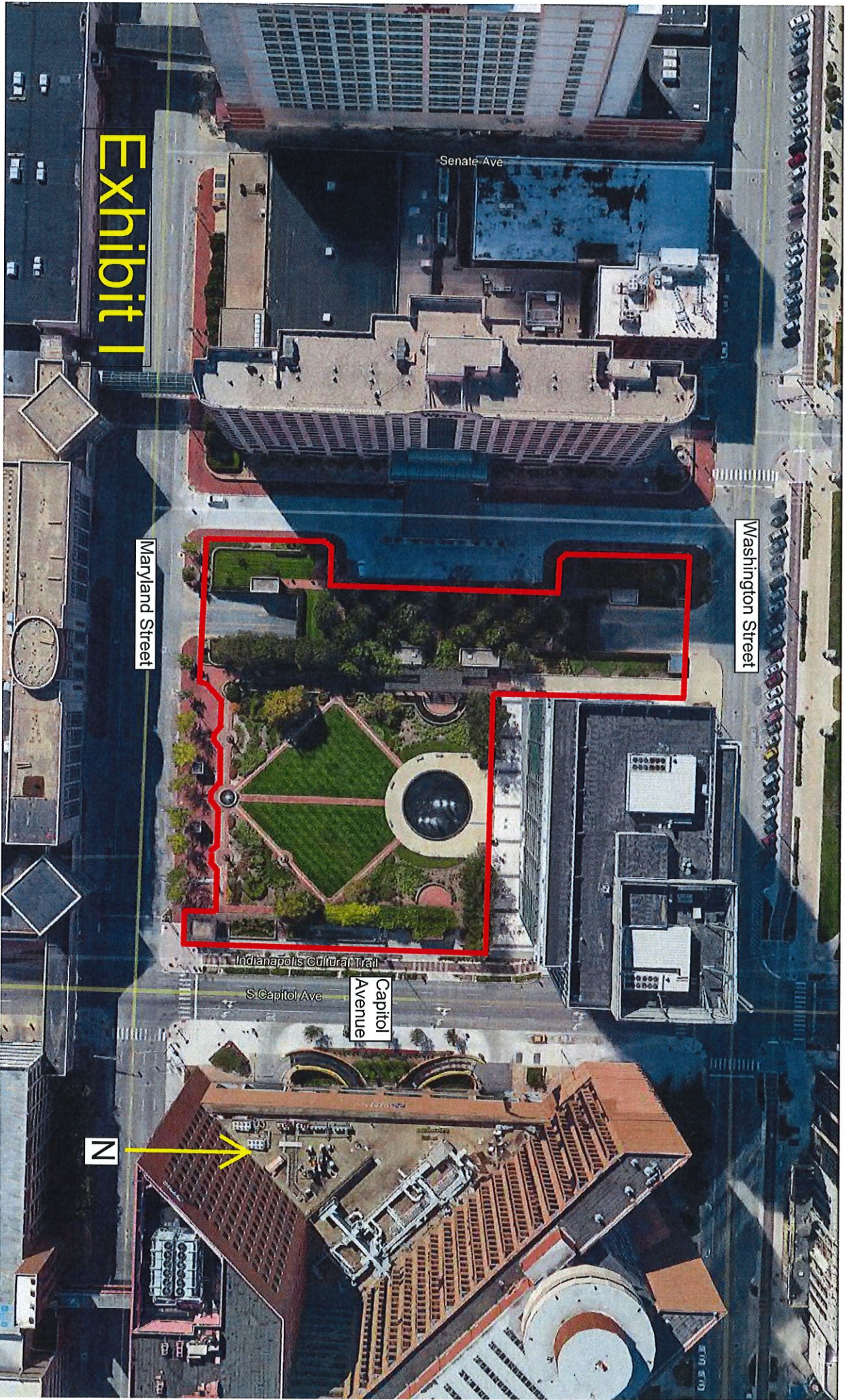
